- Over 100 hours of combined volunteer work


#### Goals of the Survey

- To assist the Village Board in setting priorities for expenditures of time and money


# Approach and Completion

- Hotline number for pickup
- 2 drop locations: Caves and the Village Office
- Each survey hand delivered
- 315 surveys delivered
- 79 surveys completed and returned (25%)


# How long have you lived in the village?

- Aftermath of 2008 mortgage meltdown


### Overall Impressions

- High completion rate


#### Issues, Concerns

- Mall plantings and upkeep




#### Most Important Village Character Element




## As a pedestrian, I believe sidewalks and streets are in good condition.




# Appearance, maintenance of streets, sidewalks, street trees important to village preservation?




## Snow removal is not a problem in my neighborhood.




## Tennis Courts, picnic area and playground offer adequate recreational space?




## Concerned with deteriorating or vacant residences and their effect on health, safety and property values in village.




## I would find a Village website and Facebook page helpful.
